Duke Energy KY East Bend Station

The Energy and Environment Cabinet, Division of Waste Management, (DWM) Solid Waste Branch (SWB) received on March 4, 2025, an application proposing to add a new waste stream of non-putrescible construction and demolition debris (CDD) waste to the existing CCR landfill at the Duke Energy KY East Bend landfill. The application has been deemed administratively complete and technical review has begun.

The name and address of the permit applicant is Duke Energy KY East Bend Station, 1000 E Main St. Rm. WP994, Plainfield, IN 46168. The name and address of the proposed facility is Duke Energy – East Bend Station located at 6293 Beaver Rd., Union, KY 46168. The permitting action is being processed at the Division of Waste Management, Solid Waste Branch, 300 Sower Blvd., 2nd Floor, Frankfort, KY 40601. The application and related information are incorporated into the administrative record.
